Monitor and control all budgets and administrative responsibilities, including investigative reports, evidence and report retention, payroll, proposals, along with policy and procedures manuals. Recruit and supervise a staff of 40 investigators, security officials, police officers, and administrative personnel.

Selected Special Investigations & Projects:

- Spearheaded undercover investigation leading to 86 arrests for trafficking cocaine and other illegal drugs. Coordinated 14 law enforcement officers working 24/7 to solve case in two weeks; set a record for this size operation.
- Developed and implemented an automated exhibit management system using the PIRS database to increase speed, security, and accuracy of investigative reporting - 54 field offices adopted system.
- Uncovered and prevented a murder plot against a well-known official, applying sharp analytical and problem-solving skills, and exhausting all available leads.
- Earned provincial recognition for uncovering and developing a solid case against an arson ring based in Somewhere, and for the apprehension of seven arsonists responsible for 21 counts.
- Created Office of Professional Standards in an effort to efficiently review policy, investigate complaints against officers, and ensure quality policing for community.
